This Amendment No. 1 is being filed jointly by the Reporting Persons and amends the Schedule 13G initially filed by the Reporting Persons with the Securities and Exchange Commission (the "SEC") on July 11, 2018 (the "Schedule 13G").

Except as set forth below, all Items of the Schedule 13G remain unchanged. All capitalized terms not otherwise defined herein shall have the meanings ascribed to such terms in the Schedule 13G.

As of the close of business on December 31, 2018, each of the Reporting Persons may have been deemed to have beneficial ownership of 358,345 shares of Common Stock, which consisted of (i) 319,384 shares of Common Stock issuable upon exercise of the Intracoastal Warrant and (ii) 38,961 shares of Common Stock issuable upon exercise of Intracoastal Warrant 2, and all such shares of Common Stock in the aggregate represented beneficial ownership of approximately 3.5% of the Common Stock, based on 9,314,982 shares of Common Stock outstanding on November 7, 2018 as reported by the Issuer, plus (2) 443,350 shares of Common Stock issued on December 7, 2018 as disclosed by the Issuer on Form D filed with the SEC on December 20, 2018, (3) 319,384 shares of Common Stock issuable upon exercise of the Intracoastal Warrant and (4) 38,961 shares of Common Stock issuable upon exercise of Intracoastal Warrant 2.
